Sling Tackles

Players when tackling should not **lift**, **sling**, **rotate** or **drive** their opponents into the ground with excessive force, resulting in the **head being in a vulnerable position**.

Cues

- Lifting opponents legs which could result in the head or the body being left in a vulnerable position
- Tackle that forces an opposition player head first towards the ground
- Tackle that pins the arms and is forceful and leaves the head in a vulnerable position. Player is unable to protect their head
- Tackle whose force is unreasonable or unnecessary in the circumstances (rotation etc.)
 tackler must show duty of care

Reporting - Red V Yellow Cards

Red Cards

Note:- misconduct covers offences not covered specifically under other laws, e.g. urinating in view of spectators, exposing themselves in front of spectators, etc.

- Those highlighted are automatic red cards the rest are open to interpretation
- For example:
 - o Jumper Punch V's King Hit behind play Red Card and must go to the tribunal
 - Player calls you a fucken idiot V's continual abuse and acting in a threatening manner
 - o Misconduct minor V's Misconduct Major
- Red Cards should be for very serious reports. Intentional striking is not a red card unless it is extreme serious (player knocked out, blood, off the ball)
- Any Red Card report must go to the tribunal

<u>Reporting Procedures – Post Match</u>

- Get all stakeholders to sign report sheet (team managers from both sides and umpire).
 - Offer set penalty but, do not worry about getting an answer.
 - If they are happy to take it great if they are not sure they have until Monday lunchtime.

- Where possible scan and attach the report sheet (take a photo on your phone if easier)

Example

- **O Details of Incident:** It was about 30seconds before the end of game when number 22 from diggers rest intentionally struck number 49 from Sunbury kangaroos. The ball was between 90- 150 meters away from the incident I would say it was intentional because there was nobody else around him.
- Report Type: 19.2.2 (a) (i) Intentional Striking
- O Umpire Assessment: Ok for Set Penalty (or) Tribunal Hearing required
- Offended Player Club Assessment: Ok for Set Penalty (or) Tribunal Hearing required
- Offending Player Club Assessment: Ok for Set Penalty (or) Tribunal Hearing required
